Tattoo Consent Form/Waiver

**Client, please read every provision and initial each box marked with an X to indicate that you understand and agree. Waiver must be completed in full to book a session. Please feel free to ask questions regarding this waiver. Waiver is 2 pages.**

In consideration of receiving a tattoo from FierceNatured Ink, LLC including its artists, associates, apprentices, agent or any employees (hereinafter referred to as the "Tattoo Studio") I agree to the following:

I, \_\_\_\_\_ (Print name) Have been fully informed of the inherent risks associated with receiving a tattoo. Therefore I fully understand that these risks, known and unknown, can lead to injury, including but not limited to: infection, scarring, difficulties in the detection of future skin cancers including melanoma, allergic reactions to tattoo pigment, ingredients in soaps, gloves, adhesive bandages, and any ointments or other products used during the tattoo process. Having been informed of the potential risks that may arise from receiving a tattoo, I wish to proceed with the tattoo procedure and application and freely accept and expressively assume any and all risks that may arise.

I waive and release to the fullest extent permitted by law any person of the Tattoo Studio from any liability whatsoever, including but not limited to any and all claims or causes of action that I, my estate, heirs, executors or assignee may have for personal injury or otherwise, including any direct and/ or consequential damages, which result or arise from the procedure and application of my tattoo, whether caused by the negligence or fault of either the Tattoo Studio or otherwise.

The Tattoo Studio has given me the full opportunity to ask any question about the procedure and application of my tattoo and all of my questions, if any have been answered to my total satisfaction.

The Tattoo Studio has provided me with written instructions on the care of my tattoo while it's healing. I understand these instructions and will follow them. I understand that it is possible that the tattoo may become infected, but is less likely to become infected if I follow these instructions properly. If any touch-up work is needed due to my own negligence, I agree that the work will be completed at my own expense.

I am not under the influence of alcohol or drugs and I am voluntarily requesting to be tattooed by the Tattoo Studio without duress or coercion. The design to be tattooed is a design that I have intentionally chosen.

I do not suffer from diabetes, epilepsy, hemophilia, Ehlers-Danlos syndrome, heart condition(s), nor do I take blood thinning medications. I am not pregnant or nursing an infant. I am not the recipient of an organ or bone marrow transplant, artificial heart valves, artificial joint replacements or any other similar procedure, or if I am, I have taken the preventative regimen of antibiotics that is required by my physician in advance of any invasive procedure. I do not have any other medical or skin conditions that may interfere with the procedure or the healing process. I do not have any mental impairment that may affect my judgment in receiving a tattoo.

The Tattoo Studio is not responsible for the meaning or spelling of the symbol or text that I have provided or chosen from the flash design sheets or any other source.

\_\_\_\_X Variations in color and design may exist between the tattoo art I have selected and the actual tattoo when it is applied to my body. I also understand that over time, the colors and clarity of my tattoo will fade due to sun exposure and the naturally occurring dispersion of tattoo pigment under the skin.

\_\_\_\_X A tattoo is a permanent change to my appearance and can only be removed by laser or surgical means. These procedures can be costly and may result in scarring. The procedures also are not likely to restore my skin to its exact appearance before receiving a tattoo.

\_\_\_\_X I release the right to any photographs taken of me and or the tattoo and give consent to their reproduction in print or electronic form. You may refuse to have your photo taken, but the finished tattoo work will be photographed in such a way to protect your identity, if you so wish.

\_\_\_\_X I agree and understand that the Tattoo Studio has a no refund policy on tattoos, piercings, and/or product sales. All transactions are final and will not be refunded.

\_\_\_\_X I agree to reimburse the Tattoo Studio for any attorney's fees and costs incurred in any legal action I may bring against the Tattoo Studio and in which the Artist of the Tattoo studio is the prevailing party. I agree that the courts located in Winneshiek County, Iowa shall have jurisdiction and venue over me and shall have exclusive jurisdiction for the purposes of litigating any dispute arising out of, and/or related to this agreement.

\_\_\_\_X I acknowledge that I have been given adequate time and opportunity to read and understand this document. That it was not presented to me at the last minute and I understand that I am signing a legal contract waiving certain rights to recover damages against the Tattoo Studio, should any arise.

If any provision, section, clause or phrase of this release is found to be unenforceable or invalid, that portion shall be severed from this contract. The remainder of the contract will then be construed as though the unenforceable portion had never been contained in this document.

\_\_\_\_X I hereby declare that I am of legal age and have provided a valid state or government issued photo ID as proof of age and identification and am competent to sign and abide by this agreement.

I have read this agreement in it's entirety, understand it, and agree to be bound by it.

I understand that if I do not agree to this waiver, or any of it's content, I will not receive tattoo services from FierceNatured Ink, LLC now, or at any time in the future.
